ORDINANCE #24-1718

AN ORDINANCE OF THE TOWNSHIP OF MONTGOMERY IN SOMERSET COUNTY PROVIDING FOR THE ACCEPTANCE OF RIGHT-OF-WAY DEDICATION OF BRECKNELL WAY

WHEREAS, Sharbell Cranbury INC., a New Jersey corporation, and SHARBELL PLAINSBORO INC., a New Jersey corporation, as Tenants in Common, (hereinafter collectively "Sharbell") are the owner of the Montgomery Crossing Development project, which project includes Block 28005, Lot 66; and

WHEREAS, Village Shoppes at Montgomery, LLC, a limited liability company of the State of New Jersey (referred to as the "Village Shoppes"), is the owner of the Village Walk project, which project includes Block 28005, Lot 68; and

WHEREAS, the Township Committee of the Township of Montgomery, County of Somerset, State of New Jersey, wishes to accept Deeds (Right-of-Way Dedication) for a portion of Block 28005, Lot 66; Block 28005, Lot 68 ("Deeds"); for that roadway commonly known as Brecknell Way; and

WHEREAS, these dedications are required by various Township of Montgomery Planning Board Resolutions; and

WHEREAS, Sharbell and Village Shoppes agreed to donate the Deeds at no cost to the Township; and

WHEREAS, the Township Attorney and Township Engineer for the Township of Montgomery reviewed the Deeds and find each acceptable.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Montgomery, County of Somerset, State of New Jersey, that it hereby authorizes acceptance of the identified Deeds.

BE IT FURTHER ORDAINED that the Township of Montgomery Mayor and Clerk are hereby authorized to sign the Deeds as may be required.

BE IT FURTHER ORDAINED that this Ordinance shall take effect upon its adoption, passage and publication according to law.
