- Item 60 – The Applicant requests a waiver from providing the operational information, as no changes are proposed to operations as part of this amended site plan.
- Item 61 – This item is not applicable to this application, as no hazardous substances will be stored on site.
- Items 62 through 66 – These items are not applicable to this application, as no clearing or construction is proposed prior to final approval.
- Item 67 – This item is not applicable to this application, as this is not a planned development.

 - The Applicant delineated the location of ponds, marshes, wetlands and other features on the Property, but requests a waiver from providing the location of same within 200 feet of the Property’s boundaries.
