ORDINANCE #24-1719

AN ORDINANCE AMENDING SCHEDULE I “NO PARKING”, SCHEDULE VII “THROUGH STREETS”, SCHEDULE VIII “STOP INTERSECTIONS”, SCHEDULE XIII “NO LEFT TURN”, AND SCHEDULE XVII “SPEED LIMITS”, OF CHAPTER VII, OF THE CODE OF THE TOWNSHIP OF MONTGOMERY (1984) TO ESTABLISH NO PARKING PROVISIONS, THROUGH STREET DESIGNATION, STOP SIGN LOCATIONS, NO LEFT TURN RESTRICTIONS, AND SPEED LIMITS ON BRECKNELL WAY

BE IT ORDAINED by the Township Committee of the Township of Montgomery, in the County of Somerset, New Jersey as follows:

Section 1. **Schedule I Amended.** Schedule I, entitled "No Parking", of Chapter VII, TRAFFIC, of the Code of the Township of Montgomery (1984), County of Somerset, State of New Jersey, which prohibits parking on certain streets or portions thereof, is hereby amended by the addition of the following streets:

Name of Street	Sides	Location
<u>Brecknell Way</u>	<u>Both</u>	<u>Entire length</u>

Section 2. **Schedule VII Amended.** Schedule VII, entitled "Through Streets", of Chapter VII, TRAFFIC, of the Code of the Township of Montgomery (1984), County of Somerset, State of New Jersey, which describes streets or parts of streets that are designated as Through Streets; in which STOP signs shall be installed on or near the right side of each street intersecting, or each entrance into the Through Street, except where YIELD RIGHT-OF-WAY signs are provided for in the designation; is hereby amended by the addition of the following streets:

Name of Street	Location
Brecknell Way	Entire Length

Section 3. **Schedule VIII Amended.** Schedule VIII, entitled "Stop Intersections", of Chapter VII, TRAFFIC, of the Code of the Township of Montgomery (1984), County of Somerset, State of New Jersey, which establishes stop intersections for streets within the Township, is hereby amended to add the following public roads:

Intersection	Location of Stop Sign
Brecknell Way at County Route 518 (Georgetown Franklin Turnpike)	Brecknell Way
Brecknell Way at U.S. Route 206	Brecknell Way

Section 4. **Schedule XIII Amended.** Schedule XIII, entitled "No Left Turn", of Chapter VII, TRAFFIC, of the Code of the Township of Montgomery (1984), County of Somerset, State of New Jersey, which establishes no left turn provisions at intersections within the Township, is hereby amended to add the following public roads:

Intersection	Turn Prohibited	Times	Movement Prohibited
Brecknell Way at County Route 518 (Georgetown Franklin Turnpike)	<u>Left</u>	<u>All times</u>	<u>Brecknell Way southbound onto Route 518 eastbound</u>
Brecknell Way at U.S. Route 206	<u>Left</u>	<u>All times</u>	<u>Brecknell Way eastbound onto Route 206 northbound</u>

Section 5. Schedule XVII Amended. Schedule XVII, entitled "Speed Limits", of Chapter VII, TRAFFIC, of the Code of the Township of Montgomery (1984), County of Somerset, State of New Jersey, which establishes speed limits for streets within the Township, is hereby amended to add the following public roads:

Name of Street	Direction	Speed	Location
<u>Brecknell Way</u>	<u>Both</u>	<u>25 mph</u>	<u>Entire length</u>

Section 6. Repealer. All ordinances and resolutions or parts thereof inconsistent with this ordinance are hereby repealed.

Section 7. Severability. If any section, paragraph, subsection, clause or provision of this ordinance shall be adjudged by the courts to be invalid, such adjudication shall only apply to the section, paragraph, subsection, clause or provision so adjudged and the remainder of this ordinance shall be deemed valid and effective.

Section 8. Effective Date. This ordinance shall take effect upon final adoption and publication in accordance with the law.
