**NOTICE TO HUNTERS REGARDING MONTGOMERY TOWNSHIP'S**  
**2023-2024 MUNICIPAL DEER MANAGEMENT PROGRAM**

Once again, Montgomery Township will make certain municipally-owned properties available to hunters during the 2023-2024 deer hunting season, for the sole and limited purpose of culling white-tailed deer. Only hunters who have applied for and received a 2023-2024 municipal deer management permit may participate in this program. To be eligible for a permit, the applicant must be at least 18 years old, provide proof of at least \$1 million in general liability insurance, and possess a current New Jersey hunting license. Any applicant who is prohibited by law from possessing a firearm, who has been convicted of a felony, or who within the past ten years has violated New Jersey's Fish and Game Code or any local rule or regulation pertaining to parks or to hunting shall not be eligible for a municipal deer management permit.

Applications and property information for municipal deer management permits and Youth Hunting permits may be requested by calling (908) 359-8211 or by downloading the form from the Township's web site, [www.montgomerynj.gov](http://www.montgomerynj.gov)

**Completed applications must be received by the Township Clerk's office starting no earlier than 8:00 a.m. on Monday May 15, 2023 and ending no later than 4:30 p.m. on Friday June 2 2023.** Applications will be logged in by the Township Clerk and processed on a first-come, first-served basis, except that any past permittee who is applying to hunt their same main property he or she hunted in the 2022-2023 season, and who met the eligibility requirements set forth in Section 9-9.e of the Montgomery Township Code will be given priority over other applicants for that particular property only.

**Farm Lease** - Several properties are subject to farming lease agreements between the Township and a private farmer, as noted below. Hunters shall not disrupt the farmer's operations, or damage, destroy or harm the farmer's crops, livestock or farming equipment.

Permits will be issued for the following properties (maps are available in the Clerk's office):

11. **Potter Tract/Rock Mill Park** (Block 10001, Lot 20 and Block 12001, Lot 39): 2 permits & 2 youth permits, bow only

The Township hereby establishes the following properties as “**provisional**” hunting tracts. Eligible hunters who meet the criteria established in Township Code Section 9-9, and who meet the following additional requirements may apply for a “provisional” property:

- 1) participated in the Township’s deer management program for at least one year, and
- 2) achieved the designated minimum quota in the previous hunting season on a “main” property or the “provisional” property for which they are applying, and
- 3) may be required to conduct an on-site meeting with a representative of the Wildlife Committee, Police Department or other Township staff to determine appropriate tree stand locations or to identify and discuss other site specific constraints.

- P1. **Bennett** (Block 31010, northern portion of Lot 9.03 & Block 31036, Lot 44): 2 permits & 2 youth permits, bow only. No hunting in the southern portion of Lot 9.03 (consult Deer Management Program Map for this property) - farm lease
- P2. **Platz** (Block 15001, Lot 26 and Block 15004, Lot 9): 2 permits and 2 youth permits, bow only - farm lease
- P3. **Montgomery Meadows** (Block 15001, Lot 43 and 43.10): 3 permits and 2 youth permits, bow only
- P4. **Saxon Ridge** (Block 16012, Lots 1.02 and 1.03): 2 permits and 2 youth permits, bow only
- P5. **Montgomery Woods** (Block 37002, Lot 2.01) 2 permits and 2 youth permits, bow only.
- P6. **East Street** (Block 15009, Lots 1-4 and 6-8): 2 permits and 2 youth permits, bow only.

- P13. **Community Center** (Block 14001, Lots 37 and 38): 1 permit and 1 youth permit, bow only - farm lease
- P14. **Former Municipal Building** (Block 6001, Lot 16) 2 permits and 2 youth permits, bow only
- P15. **River Road Pump Station** (Block 7019, Lot 64): 1 permit and 1 youth permit, bow only
- P16. **Fieldcrest** (Block 15001, Lot 70): 1 permit and 1 youth permit, bow only
- P17. **Back Brook** (Block 17001, Lots 6.86, 6.87 and Block 21001, Lot 1.14): 2 permits and 2 youth permits, bow only

- P18. **Opossum Road Woods** (Block 27001, Lots 12, 19.01, 19.02 and 19.03): 2 permits and 2 youth permits, bow only; **The Township will be undertaking a demolition project in connection with this property. Hunting will not be permitted during demolition activities. Permittees will be notified in writing when hunting on this property will not be permitted.**
- P19. **Camp Meeting Avenue** (Block 25001, Lot 7 and Block 12001, Lot 17): 1 permit and 1 youth permit, bow only
- P20. **Van Zandt** (Block 25001, Lots 28.08 and 28.13): 2 permits (no youth), bow only
- P21. **206 Farmview** (Block 20001, Lot 4): 1 permit (no youth), bow only
- P22. **Bronson** (Block 16014, Lot 17): 1 permit (no youth), bow only

The applicant must indicate on the application form which property he or she is applying for. A separate application is also required for any of the **provisional** restricted permits. Only one permit per applicant will be issued, except that a provisional restricted permit may also be issued to a 2023-2024 permittee pursuant to the terms set forth above and in Township Committee Resolution #23-4-117. All permit applicants are urged to familiarize themselves with said resolution prior to submitting applications. Applicants should consult the Deer Management Program Maps available in the office of the Township Clerk.

Unless otherwise indicated above, properties may be hunted during all of the State's regular deer hunting seasons for zones 12 and 14.

Successful applicants will be notified by the Township Clerk's office. All successful applicants, including returning permittees, will be required to complete Montgomery's hunter orientation & safety course prior to receiving a permit. **The hunter orientation & safety course will be offered in person at the Council Chambers at the Montgomery Municipal Complex (100 Community Drive, Skillman NJ 08558) on Wednesday July 26, 2023 at 7:00 p.m.**

**Dates are subject to change – please confirm with Township Clerk. No permit will be issued unless the applicant completes this course. **You should not apply if you cannot make this date.****

At the conclusion of the orientation course, permittees will receive the following: a Montgomery Township municipal deer management permit for their specific property and, if applicable a provisional permit; a copy of the applicable rules and regulations; a map of the property for which the applicant has received a permit; a set of warning signs and a parking permit. No hunting whatsoever may take place until after the permittees have posted the perimeter of their properties with these warning signs.

The cost for each permit is \$100.00, payable by check or money order made out to the Township of Montgomery. The cost for each youth permit is \$50.00, payable by check or money order made out to the Township of Montgomery.

The cost for each provisional permit is \$100.00, payable by check or money order made out to the Township of Montgomery.

**RULES AND REGULATIONS**

All State and local regulations pertaining to parks and to hunting apply, including specific season dates and bag limits for deer management zones 12 and 14. In addition, the following special regulations apply:

1. The boundaries of each property must be posted by the permittees prior to any hunting beginning on that property (boundary signs will be provided by the Township).
2. Only portable stands that do not harm trees will be permitted, and they must be removed fifteen (15) days after the end of hunting season.
3. Deer must be registered via the State Automated Harvest Reporting System and subsequently reported to the Township's Wildlife Committee email ([wildlifecommittee@montgomerynj.gov](mailto:wildlifecommittee@montgomerynj.gov)) within 72 hours of harvest. A picture must be included with your email as well as your hunter ID number, harvest confirmation number, and property name. Please retain a copy of your confirmation number(s). You will be required to report the number(s) on your end of year questionnaire.
4. Each permittee will be required to complete an end-of-year questionnaire for each property hunted. Completion and submission of the questionnaire by the established deadline is a mandatory requirement for participating in the program the following season.
5. Only deer may be hunted; any other hunting is strictly prohibited, except as permitted below.
6. Hunters are only authorized to be on the property for which they have been issued a permit, unless participating in a deer drive pursuant to number 6 below, and are responsible for knowing where they are at all times. Each hunter's permit must be prominently displayed whenever the hunter is on the property.
7. Deer drives are permitted as long as a hunter has been issued a license for that specific property. Any hunter who has been issued a permit for that property may carry a bow or firearm during the drive; hunters who have not been issued a permit for that property may participate in the drive, but may not carry any weapon while doing so. **No hunter may participate in any deer drive on any public property unless he or she has been issued a deer management permit by the Township of Montgomery.**
8. Vehicles are restricted to public roads and designated parking areas, unless a specific exception has been granted by the Township (map will be provided).
9. Target practice is prohibited. The legal discharge of a crossbow into a portable target at the hunt's end is not considered to be target practice.
10. Use or possession of alcoholic beverages while on the property is prohibited.
11. Littering is prohibited.
12. All State and local rules and regulations pertaining to parks and to hunting apply.
13. Violation of any special condition or any applicable State law or local regulation will result in the immediate loss of hunting privileges on the property and will also subject the hunter to any applicable penalties.
14. Hunting is restricted to the portions of the properties designated as open to deer hunting (maps will be provided).
15. All permittees must check in at (908) 533-9297 prior to hunting any property. This procedure is required each time the permittee intends to hunt.
16. Only one (1) deer stand per hunter. Stands **MUST** have Township ID tag attached.
17. The taking of a coyote and/or a fox while engaging in deer hunting on Township property is permissible, provided that hunters abide by all State regulations on coyote and fox hunting. Coyote and fox hunting on Township property shall be incidental to, and not separate from, deer hunting and shall conclude on the last day of the deer hunting season. The hunting of coyote or fox at night is strictly prohibited. *The hunting, shooting or killing any other game is strictly prohibited.*
18. Properly licensed persons hunting deer who have a valid turkey season permit from the NJ Division of Fish and Wildlife are authorized to take turkeys of either sex during the one week of the permit bow season that coincides with the fall turkey season. Turkey hunting on Township property shall be incidental to, and not separate from deer hunting during that one week period.
19. **Farm Lease** - Several properties are subject to farming lease agreements between the Township and a private farmer. Hunters shall not disrupt the farmer's operations, or damage, destroy or harm the farmer's crops, livestock or farming equipment.

Hunters are not permitted to hunt or possess a loaded firearm within 450 feet of any building or school playground.

Hunting may begin one half hour before sunrise and must end one half hour after sunset.

Hunting is not permitted on Sundays.

  - The Township Clerk will log in the applications in the order in which they are received; only complete applications will be logged in. Permits will be issued to eligible applicants on a first-come, first-served basis, except that any past permittee who is applying to hunt the same property he or she has previously hunted and who meets the eligibility requirements set forth in Section 9-9.e of the Montgomery Township Code will be given priority over other applicants for that property only.

- Signed release authorizing the Township to conduct a background check for violations of the New Jersey Fish and Game Code (see attached form);
- A copy of a certificate of insurance confirming general liability insurance with coverage with combined single limits for bodily injury and property damage of at least one million dollars per single occurrence and one million dollars annual aggregate;
- \$100.00 application fee (if paying by check or money order, make it payable to the Township of Montgomery).
