- Provides in-depth involvement in their jurisdiction's Community Health Assessment and Community Health Improvement Plan (CHIP), including CHIP implementation and evaluation
- Participates in community partnerships
- Provides Health education programs for community issues that are not addressed in the CHIP, if applicable
- Maintains an inventory of health and human service resources
- Provides in-service training programs for staff, volunteers, and other interested parties
- Crafts communications that are culturally appropriate and communicated in a language and format that the population can access and understand
- Works with Health Officer and/or Public Information Officer regarding media outreach.
- Assists with Risk communication plans to manage community concern and convey appropriate and accurate information
- Advocates for policies and funding that will improve the health status of communities
- Participation in grant writing to support local health department objectives, the CHIP, and health promotion initiatives.
- Provides oversight to the Municipal Alliance for the Prevention of Substance Abuse.
- Respond to Public Health Emergencies as needed.
- The job duties, responsibilities, skills and descriptions herein are not comprehensive. Duties may be added or removed at the Township's discretion.
